2013-270 CONTINUE A PUBLIC HEARING TO CONSIDER AND ACT UPON AN ORDINANCE FOR A REVISED ZONING ORDINANCE TO REPLACE THE CURRENT ORDINANCE 89-13, AS AMENDED, TO REFORMAT AND REORGANIZE THE EXISTING ZONING ORDINANCE BY CREATING NEW SECTIONS AND SUBSECTIONS, AND INCLUDING ILLUSTRATIONS (CASE NO. OZ03-2012-43)

Mayor Houston opened the Public Hearing and John Taylor presented the Item that creates a new structure for the existing Zoning Ordinance intended to simplify and create ease of use for the general public. With no public input received, Councilmember Sibley moved to close the public hearing. Motion was seconded by Mayor pro tem Frizzell and carried unanimously (6-0). Mayor pro tem Frizzell moved to approve Item 2013-270 as presented. Motion was seconded by Councilmember Sibley and carried unanimously (6-0).

2013-271 CONDUCT A PUBLIC HEARING AND ACT UPON AN ORDINANCE REQUESTING TO REZONE ± 12 ACRES FROM MEDIUM INDUSTRIAL (MI) AND AGRICULTURAL (A) TO HEAVY INDUSTRIAL (HI) DISTRICT. PROPERTY IS LOCATED IN J.E. HAWKINS SURVEY, ABSTRACT 461 AND THE JOHN W. BURKS SURVEY, ABSTRACT 113 AND IS LOCATED ± 2,475 FEET NORTHEAST FROM THE EASTERN END OF KEMP RANCH CROSSING, IN THE CITY OF MIDLOTHIAN, TEXAS (CASE NO. Z11-2012-72)

Mayor Houston opened the Public Hearing and John Taylor presented the Item that will ultimately allow a petroleum storage facility on the subject property. On June 18, 2013, the Planning and Zoning Commission unanimously recommended approval of the rezoning request. With no public input received, Councilmember Sibley moved to close the public hearing. Motion was seconded by Mayor pro tem Frizzell and carried unanimously (6-0). Councilmember Sibley moved to approve Item 2013-271 as presented. Motion was seconded by Mayor pro tem Frizzell and carried unanimously (6-0).

2013-272 CONDUCT A PUBLIC HEARING AND ACT UPON AN ORDINANCE FOR A SPECIFIC USE PERMIT TO ALLOW A PETROLEUM STORAGE FACILITY ON ± 12 ACRES ON PROPERTY ZONED HEAVY INDUSTRIAL (HI). PROPERTY IS LOCATED IN J.E. HAWKINS SURVEY, ABSTRACT 461 AND THE JOHN W. BURKS SURVEY, ABSTRACT 113 AND IS LOCATED ± 2,475 FEET NORTHEAST FROM THE EASTERN END OF KEMP RANCH CROSSING, IN THE CITY OF MIDLOTHIAN, TEXAS (CASE NO. SUP06-2012-73)

Mayor Houston opened the Public Hearing and John Taylor presented the Item that will allow Buckley Oil to operate a petroleum storage facility on this site. The Planning and Zoning Commission unanimously recommended approval of the SUP on June 18, 2013. With no public input received, Councilmember Sibley moved to close the public hearing. Motion was seconded by Mayor pro tem Frizzell and carried unanimously (6-0). Councilmember Henley moved to approve Item 2013-272 as presented. Motion was seconded by Councilmember Miller and carried unanimously (6-0).

2013-273 CONDUCT A PUBLIC HEARING TO CONSIDER AND ACT UPON AN ORDINANCE DESIGNATING A CERTAIN AREA AS A REINVESTMENT ZONE FOR COMMERCIAL-INDUSTRIAL TAX ABATEMENT IN THE CITY OF MIDLOTHIAN, TEXAS TO BE KNOWN AS THE TEXAS RAILPORT COMMERCIAL-INDUSTRIAL TAX ABATEMENT REINVESTMENT ZONE NO. 6, CITY OF MIDLOTHIAN, TEXAS; ESTABLISHING THE BOUNDARIES THEREOF; AND PROVIDING FOR AN EFFECTIVE DATE

Mayor Houston opened the Public Hearing and Larry Barnett presented the Item requesting the creation of the reinvestment zone. With no public input received, Councilmember McClure moved to close the public hearing. Motion was seconded by Councilmember Henley and carried unanimously (6-0). Councilmember Henley moved to approve Item 2013-273 as presented. Motion was seconded by Councilmember McClure and carried unanimously (6-0).

2013-274 CONSIDER AND ACT UPON A RESOLUTION AUTHORIZING EXECUTION OF AN AD VALOREM TAX ABATEMENT AGREEMENT WITH BUCKLEY PROPERTY COMPANY

Larry Barnett presented the tax abatement agreement on behalf of Buckley Oil Company aka Buckley Property Company. The proposed tax abatement will be for eight years, with a 55% abatement for year one and 50% abatement for years two through eight. The first year of the tax abatement would begin January 1 after construction is complete and a certificate of occupancy is issued by the City of Midlothian. Councilmember McClure moved to approve Item 2013-274 as presented. Motion was seconded by Councilmember Henley and carried unanimously (6-0).

2013-275 CONSIDER AND ACT UPON A LOAN AGREEMENT BETWEEN BUCKLEY PROPERTY COMPANY AND MIDLOTHIAN ECONOMIC DEVELOPMENT AMOUNTING TO \$200,000, WITH AN EIGHT (8) YEAR TERM, AND WITH TWELVE AND ONE-HALF PERCENT (12.5%) OF THE ORIGINAL LOAN AMOUNT BEING FORGIVEN YEARLY, UP TO THE LOAN MATURITY DATE, PROVIDED CERTAIN CRITERIA ARE CERTIFIED AS MET, YEARLY, BY THE COMPANY

Larry Barnett presented the loan agreement that was approved by the Midlothian Economic Development Board of Directors on June 17, 2013. Mr. Barnett explained that this type of loan agreement has been utilized with other businesses that have located in Midlothian, such as Target, Toys R Us and SWFA as a means of stimulating investment in the local economy. Councilmember Sibley moved to approve Item 2013-275 as presented. Motion was seconded by Councilmember McClure and carried by a vote of 5-1 with Councilmember Miller voting in opposition.

2013-276 CONSIDER AND ACT UPON A PUBLIC IMPROVEMENT PARTICIPATION AGREEMENT BETWEEN THE CITY OF MIDLOTHIAN AND KG SABLE DEVELOPMENT, LLC FOR THE ALLEN STREET LIFT STATION AND FM 663 CORRIDOR SANITARY SEWER MAIN CONSTRUCTION IN AN AMOUNT NOT TO EXCEED \$450,000 AND FOR THE EXTENSION OF BELMONT DRIVE TO S. 14TH STREET

Mike Adams presented the agreement for approval. Councilmember Miller moved to approve Item 2013-276 as presented. Motion was seconded by Councilmember Sibley and carried unanimously (6-0).

2013-277 CONSIDER AND ACT UPON AUTHORIZING DON HASTINGS, CITY MANAGER, ACTING ON BEHALF OF THE CITY OF MIDLOTHIAN, TO EXECUTE THE "DOVE LANE REALIGNMENT AGREEMENT BETWEEN THE CITY OF MIDLOTHIAN AND ASH GROVE CEMENT COMPANY," FOR THE SEGMENT OF DOVE LANE BETWEEN US HIGHWAY 67 AND N. 9TH STREET

Mike Adams presented the request for the realignment which will enable Ash Grove to have access to future limestone reserves. Ash Grove will convey new right-of-way to the City within 30 days after the effective date of the realignment agreement. Mayor pro tem Frizzell moved to approve Item 2013-277 as presented. Motion was seconded by Councilmember Sibley and carried unanimously (6-0).

2013-278 CONSIDER AND ACT UPON A BID AWARD TO XIT PAVING AND CONSTRUCTION, INC. FOR THE JUSTICE CENTER ACCESS DRIVEWAY IN A TOTAL ALTERNATE BID AMOUNT OF \$164,774.29 AND CHANGE ORDER NO. 1 IN A DEDUCTIVE AMOUNT OF \$25,339.52, FOR A REVISED TOTAL CONTRACT AMOUNT NOT TO EXCEED \$139,434.77

2013-281 CONSIDER AND ACT UPON THE SITE PLAN, BUILDING ELEVATIONS, AND LANDSCAPE PLANS FOR A MIDTOWNE ASSISTED LIVING AND MEMORY CARE FACILITY, CONTAINING ± 3.5 ACRES, LOCATED ON THE EAST SIDE OF SOUTH 9TH STREET AND APPROXIMATELY 150 FEET SOUTH OF GEORGE HOPPER ROAD, IN THE CITY OF MIDLOTHIAN, TEXAS (CASE NO. John Taylor presented the proposed site plan that was approved by the Planning and Zoning Commission on June 18, 2013. Councilmember Sibley moved to approve Item 2013-281 subject to the following amendments and conditions:

- 1. A minimum five-foot (5') landscaping strip to be required along the north side of subject property. Landscaping on the southside of the development to be deferred until the south side develops, pending the location of drive cuts.
- 2. The north side of the development will be curbed and access will not be provided to property located on north side of development until such time as property, which is currently a parking for First Methodist Church, is developed.
- 3. Concrete walkways on front side of development may be stamped concrete and walkways located at rear of development, between development and senior housing facility, are to be smooth concrete.

Motion was seconded by Mayor pro tem Frizzell and carried unanimously (6-0).
