Must be a citizen of the United States. (Debe ser ciudadano de los Estados Unidos)</li> <li>2. Must be a qualified voter of the State of Texas. (Debe ser un votante calificado del Estado de Texas)</li> <li>3. Must have resided at least six (6) months next preceding the election within the corporate limits of the City of Midlothian. (Debe haber residido al menos seis (6) meses antes de la elección dentro de los límites corporativos de la Ciudad de Midlothian.)</li> <li>4. Must be at least twenty-one (21) years of age. (Debe tener al menos veintiún (21) años de edad.)</li> <li>5. Must not be in arrears in payment of taxes or other liabilities due the City of Midlothian. (No debe estar atrasado en el pago de impuestos u otras obligaciones adeudadas a la Ciudad de Midlothian.)</li> <li>6. Must not have been convicted of a felony. (No debe haber sido condenado por un delito grave)</li> <li>7. Must not be disqualified by reason of any provision of any other section of this Charter. (No debe ser descalificado por razón de cualquier disposición de cualquier otra sección de esta Carta.)</li> </ol>
